

PRIVACY POLICY

We have set forth a comprehensive Online Privacy Policy that governs all information collected by us or submitted to our Site (www.greenwebsol.com). INFORMATION WE COLLECT AND IT'S USAGE

Aggregate / Anonymous Information As is true of most web sites, we gather certain information automatically and store it in log files. 3 COOKIES AND OTHER TRACKING TECHNOLOGIES A cookie as you know is a text file that is temporarily stored on your system hard-disk or device so that the browser installed on your machine can connect with the desired Web server in a seamless manner. We use both session ID cookies and persistent cookies. A session ID cookie expires when you close your browser. A persistent cookie remains on your hard drive for an extended period of time. We use cookies to help us to track your preferences, which is substantial for us in making the Web site more relevant or friendly and useful to your searches. You can remove persistent cookies by following directions provided in your Internet browser's "help" directory.
